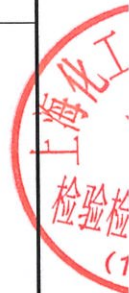

These devices are not capable of generating a dangerous evolution of heat. When active, these devices must meet defined standards for electromagnetic radiation to ensure that the operation of the device does not interfere with aircraft systems. The devices must not be capable of emitting disturbing signals (such as buzzing alarms, strobe lights). Where multiple pieces of equipment are packed in the same outer packaging, the equipment must be packed and protected against contact with other equipment so as to prevent damage.</p>

This requirement does not apply to: —packages containing only button cell batteries installed in equipment (including circuit boards); or —consignments of two packages or less where each package contains no more than four cells or two batteries installed in equipment.</p>
